National Platforms

In coffee producing countries, the GCP supports public and private sector actors to establish National Platforms, coordination boards and sustainability curricula.

The National Platforms serve as the place where regional coffee stakeholders can create a common roadmap and language on sustainability for their own country.



Production & Processing

The GCP enables coffee stakeholders to adopt a globally referenced set of baseline principles and practices for coffee production and processing.

The Baseline Common Code can underpin national sustainability strategies, be taken up by operators at national and international levels, and can enable credible reporting and comparable data within the Global Progress Framework.

The Global Coffee Platform also facilitates cross-platform learning through a large number of channels that include forums, webinars, learning journeys, and research publications.
